VOTING PLACES

The voting place will be open for voting on **Wednesday** the **28th** day of **October 2026** between 8:00 a.m. and 8:00 p.m. at: **the Town of Snow Lake Council Chambers, 113 Elm Street** (location of voting places)

IDENTIFICATION MAY BE REQUIRED BEFORE BEING ALLOWED TO VOTE. A person may be required to produce one piece of government issued photo identification (for example - driver's license or passport) or at least two other documents that provide proof of identity.

ADVANCE VOTING

For the purpose of accommodating persons who are qualified to vote, but who have reason to believe that they will be absent or otherwise unable to attend their proper voting place on election day, an advance voting opportunity will be located at **the Town of Snow Lake Council Chambers, 113 Elm Street** and will be on **Wednesday** the **21st** day of **October 2026** between 8:00 a.m. and 8:00 p.m.

APPLICATION TO VOTE BY SEALED ENVELOPE

A voter who is unable to go in person to the voting place or vote in advance, may apply in person, in writing, or by email to the senior election official at the Town of Snow Lake Town Office, 113 Elm Street, or snowlake@mymts.net.

If applying in person*, a voter may apply between September 30, 2026 and October 25, 2026.

*A voter applying in person may pick up a sealed envelope ballot package at the time of application.

If applying by mail or email**, a voter may apply between September 30, 2026 and October 25, 2026.

** A voter applying by mail or email will receive a sealed envelope ballot package by regular post, or by making alternative arrangements with the senior election official.
